Oak Island Photography & Weddings Agreement

This agreement, made this ____ day of _____, 20____ by and between Oak Island Photography & Beach Wedding Planners, hereinafter referred to as OIP, and _____ and _____ hereinafter referred to as the Couple.

Wedding date shall be _____ at _____ o'clock at the location of, The Point, Oak Island, NC. Or _____ (\$250 fee for other location)

WITNESSETH: In consideration of the mutual covenants and agreement herein contained, OIP and the Couple hereby agree to the following terms and conditions:

OIP will provide the following services: Please cross out any services you do not wish to have. Remember, the price still remains the same!

Minister

(non denominational minister will perform religious or non religious ceremony)

Sand Ceremony

(Includes glass container for you to keep forever) Professional Photographers (includes, 50 4x6, and all digital files)

Video of wedding put to DVD

(Includes a video of your wedding put to DVD. This is NOT an edited video)

Beachfront Decorations

(includes 30 chairs with white covers, 4 lit tiki torches, aisle lined with conch shells, white decorated arch.)

Music/Guitarist

(Prelude music, the Wedding March, and more!! If the guitar player is not available, recorded music will be provided)

Two Tiered Beach Wedding Cake,

(will feed 75 people) (includes a basic beach themed wedding cake, delivered and set up to your location)

Sparkling Cider for toast.

(we will provide 2 flutes)

White Doves.

(One or two white doves will be present and possibly released, if doves are not available , a shell throwing ceremony will be performed)

Wedding Party - Up to four bridesmaids and four groomsmen and two children only!

Permits - We will get all permits necessary to perform the ceremony on the beach.

The color scheme will be all white, and may include a few pastel colors. Unfortunately we are unable to provide custom color decorations. Consultation via email and phone is included.

THE COUPLE'S RESPONSIBILITIES:

The Couple understands that they must obtain a Marriage License at the appropriate jurisdiction for which the ceremony will be performed and shall provide such Marriage License to OIP to review and execute on the day of the ceremony. OIP cannot and will not perform a marriage ceremony without receiving the appropriate valid Marriage License PRIOR to the ceremony.

The Couple shall not change the date, time or location of the wedding ceremony as listed in this agreement. The Couple also understands and recognizes that OIP performs other wedding ceremonies for other couples and such change of date, time, or location, without first notifying OIP, or any excessive lateness (over 15 minutes) of the originally scheduled wedding ceremony time may create a serious conflict with OIP's schedule that may prevent OIP from performing the ceremony. If the Couple does change the date, time or location of the scheduled wedding ceremony, and OIP is unavailable to perform the ceremony, then OIP reserves the right to cancel the performance of the ceremony, and shall in no way be held responsible or liable in any manner whatsoever for non-performance. The Couple also forfeits the deposit for non-compliance with this agreement.

The Couple agrees to pay a ceremony performance fee of \$2,700 plus any mutually agreed upon additional services or unusual travel expense that OIP may incur. To reserve the above date, a

retainer fee in the amount of \$200 shall be remitted with this agreement (made payable via PayPal) The remaining balance is to be paid to OIP.

1. Under NO circumstances will any other cameras be allowed to take pictures during the wedding. WHY: This is going to be your special day. I have taken gorgeous shots with the bride and groom walking down the aisle, etc. Unfortunately, when I developed the film, there were several guests who had cameras to their eyes, snapping shots. This looked horrible!!! The last thing you want is pictures with your guests snapping photos! I am sure you want to see their faces too! Please have someone ask your guests in advance to refrain from taking pictures. IF ANYONE IS TAKING PICTURES WITH THEIR PERSONAL CAMERA THEY WILL BE ASKED TO STOP. IF THEY DO NOT STOP, WE WILL ASSUME YOU WANT THEM AS THE PHOTOGRAPHER, AND WE WILL STOP TAKING PICTURES AND PACK UP OUR CAMERAS.

2. Once the ceremony is over, I will photo you and your family and wedding attendants. This will take approximately 30 minutes, as I take some really cool, intimate shots. Once again, I ask that there are no

me to take you picture, a. you don't know who to look at and smile and b. it takes away time from your photographer! Plus, you've opted for the digital files, so they can have as many pictures of the wedding as they would like. I'll even upload them to Walmart.com for you and send you the link via email. This way you can email them the link and they can access to them all as well!

3. When the wedding and photo sessions are over, your guests are more than welcome to take as many pictures as they'd like. They can even put you in the same poses as I did! Once the reception begins, they can take as many pictures with their own cameras as they wish.

4. Please keep in mind that you have paid for a wedding with 60 minutes of photography. If you should decide that you would like for the photographer to stay longer, there will be an additional \$100 per half hour, depending upon the photographer's availability.

5. The photographer will take pictures of the couple, the bridal party, parents and grandparents. Due to the light, we do not have time to take individual family pictures. We will take one big group picture as well. We will focus on the bride and groom for approximately 20 - 30 minutes after the ceremony.

6. Call 910.538.6589 two days prior to the wedding date. We just want to confirm weather conditions, locations, etc.

7. When your guests arrive, about 10 minutes prior to the start of your wedding, everything will be set up! The groom should arrive 15 minutes prior to the start of the wedding, and pay the director the remaining balance. It should be CASH the day of the wedding.

8. This package includes unlimited email consultations and five phone consultations.
9. Make sure you drink LOTS of water the night before and day of your wedding. You do not want to become dehydrated while standing in the sun! Also, drinking water the night before makes your skin look really refreshed and healthy, which will help your pictures!
10. PAYMENT: It should be cash the day of, or if you pay with check it needs to be no later than 10 days prior to your wedding date. NO Credit cards. If you choose to bring a cashier's check, please make it payable to: Oak Island Photography Please approach us with final payment. We really don't like to
11. Normally, the groom will arrive 15 minutes prior to the wedding. The minister will introduce herself and give him brief instructions. Once the bride arrives, the minister and director will meet her in the parking lot and give her directions as well. You will be directed as to when to walk, where to stand, and what to say.
12. Your photos will be ready in a few days. Your photographer should tell you when to expect them. Please keep in mind, that you will only like about 1 out of every 10 photos. You can pick them up from the gold drop box at: 5008 Unit 1 East Oak Island Drive.
13. In the event that there is bad weather,... we can use the South Harbour Village Chapel in Southport, NC when available. A.) If there is a wedding going on, we will have to wait until it is complete prior to starting yours B.) I ask that you make a donation to the church for allowing us to use it.
14. We will pack up, clean up and take care of all the aftermath, you just go be with your family and friends and enjoy your day.
15. A \$200 nonrefundable deposit is due at time of booking. This is refundable due to extreme weather conditions. (Hurricanes)
16. Tipping: While not required, everyone likes to be rewarded for a job well done. ??
17. Final Instructions: You must fill out this form exactly 10 days prior to your wedding. DO NOT DO IT ANY SOONER THAN 10 DAYS AS IT WILL BE THROWN OUT.

The Couple gives permission and shall allow OIP to post a photograph(s), video, or media of them with OIP on OIP website, media or any other promotional material. The Couple acknowledges that this is for promotional purposes only and they do not expect any compensation of any kind. There shall be no expiration period for this permission.

OIP gives permission and shall allow the Couple to use and reproduce any photographs, videos or other recording media in which OIP is in, or part of, in any manner or for any purpose they wish. Keep this agreement as it will serve as your copyright release.

This agreement or any attachments constitutes the entire agreement between the parties and may not be modified except in writing signed by both parties or by the acknowledgement of e-mail received by both parties. No other representations or promises have been made except those that are set out in this agreement. If any part of this agreement is adjudged invalid, illegal, or unenforceable, the remaining parts shall not be affected and remain in full force and effect.
